Part-time Physical Training Assistant (Foundation Training)

(Salary: HK \$188 per hour)

Entry requirements:

- Candidates should:
 - (a) be retired Police Constables (PCs) who have ceased work in the Hong Kong Police Force for not more than three years at the time of close of application or retiring PCs on final leave;
 - (b) have a reasonable standard of physical fitness and have training experience;
 - (c) have knowledge on the use of contemporary training methods;
 - (d) have a high degree of self-discipline and initiative, and have good interpersonal, communication and presentation skills; and
 - (e) have a good record of service.
- 2. Preference will be given to candidates who:
 - (a) possess relevant qualifications in the fields of physical exercise studies, sports science or a health related discipline; and
 - (b) are willing to work irregular hours.

Notes: (a) Selected candidate will be required to work at a schedule arranged by the supervisor and the number of working hours is subject to the operational needs. There is no guarantee on the minimum number of hours of work in any given period; (b) Staff employed under Post-retirement Service Contract Scheme (PRSC) are subject to the same rules and regulations on conduct matters as applied to civil servants. Staff who have neglected or willfully refused to perform their duties or misconducted themselves in any manner are liable to disciplinary sanctions.

Duties:

A Part-time Physical Training Assistant (Foundation Training) is mainly deployed to:

- 1. assist Physical Training Instructors (PTIs) in arranging physical training and first aid training for Recruit Police Constables (RPCs) and Probationary Inspectors (PIs) in accordance with the syllabus, and provide administrative and logistical support in the PIs' Outdoor Personal Development and Adventure Training and RPCs' outdoor mindset training activities;
- 2. assist PTIs in conducting physical fitness tests for PIs and RPCs;
- 3. assist PTIs in conducting physical fitness tests for recruitment purposes;
- 4. provide logistical support in Force-wide sports and charitable events;
- 5. provide first aid services and advice on the use of contemporary training methods;
- 6. assist in liaising and coordinating with the relevant parties for visits to the Physical Training and First Aid (PT&FA) Unit; and
- 7. perform any other duties as assigned by the senior officers.

Terms of Appointment: Successful candidate will be appointed on non-civil service contract terms under the Post-retirement Service Contract Scheme for 12 months.

How to Apply: Application Forms (G.F. 340 (Rev. 7/2023)) are obtainable from any Home Affairs Enquiry Centre of District Offices, Home Affairs Department or any Job Centre of the Employment Services Division, Labour Department. If candidates submit the old version form (G.F. 340 (Rev. 3/2013)), they will be required to fill in the new G.F. 340 (Rev. 7/2023) afresh and submit it within seven days upon request. If candidates fail to

submit the new G.F. 340 (Rev. 7/2023) within the stipulated deadline, their applications will not be processed further.

Applicants should state clearly on the form <u>and</u> the envelope which position they are applying and affixed with sufficient postage before posting so as to avoid unsuccessful delivery of application. **Mail items bearing insufficient postage will NOT be delivered to us and will be handled by the Hong Kong Post in accordance with the Post Office Ordinance**. Suspension of Monthly Pension and Eligibility for Medical and Dental Benefits: The payment of the employee's monthly pension / retirement allowance will be suspended under Hong Kong Pensions legislation during the period of employment, including leave earned during that period, unless and until the employee has reached the applicable normal or prescribed retirement age prescribed in the relevant pension legislation. When the employee is not in receipt of a pension or an annual allowance during the period of suspension of monthly pension / retirement allowance, he / she and his / her family are not eligible for civil service medical and dental benefits during the period concerned.

No Double benefits rule: Under the policy on prevention of double benefits, civil servant **who is re-appointed to the Government during his / her final leave period** should not be allowed to receive two sets of fringe benefits for the overlapping period (except for the statutory compensation and statutory benefits such as MPF benefits). The employee is required to forgo his / her right to civil service pension benefits / gratuity and all other civil service benefits during his / her final leave period of his / her civil service employment during the period concerned.

Where the retiring civil servants taking up PRSC positions are pensionable officers, if their PRSC employment carries any form of fringe benefits (except for statutory compensation and statutory benefits such as MPF benefits), the overlapping period between the PRSC employment and the final leave period should not be counted as pensionable service for computation of pension benefits upon retirement.

General Notes: (a) Candidates must be permanent residents of the Hong Kong Special Administrative Region at the time of appointment unless specified otherwise. (b) As an Equal Opportunities Employer, the Government is committed to eliminating discrimination in employment. The vacancy advertised is open to all applicants meeting the basic entry requirement irrespective of their disability, sex, marital status, pregnancy, age, family status, sexual orientation and race. (c) Post-retirement service vacancies are not posts on the civil service establishment. Candidates appointed are not on civil service terms of appointment and conditions of service. Candidates appointed are not civil servants and will not be eligible for posting, promotion or transfer to any posts in the Civil Service. (d) The entry pay, terms of appointment and conditions of service to be offered are subject to the provisions prevailing at the time the offer of appointment is made. (e) Where a large number of candidates meet the specified entry requirements, the recruiting department may devise shortlisting criteria to select the better qualified candidates for further processing. In these circumstances, only shortlisted candidates will be invited to attend selection interview. (f) It is Government policy to place people with a disability in appropriate jobs wherever possible. If a disabled candidate meets the entry requirements, he / she will be invited to attend the selection interview without being subject to any further shortlisting criteria.
